**A- Technical Requirement:-**


- i. The bidder should have a valid Class 'A' Electrical License Holder.
- ii. The bidder should have **successfully completed the turnkey/semi-turnkey work along with their completion certificate of the following nature in the last three financial year as prime contractor from the date of opening of bid part-1:-**
  1. Should have successfully erected and commissioned similar or higher rating work in a single turnkey/semi turnkey order, having minimum order value of 80% of the estimated cost of the present tender specification, **(80% of Rs. 10.25 Lakh i.e. Rs. 8.20 Lakh)** or
  2. Should have successfully erected and commissioned similar or higher rating work in maximum two turnkey/semi turnkey order, having minimum order value of 50% each of the estimated cost of the present tender specification, **(50% of Rs. 10.25 Lakh i.e. Rs. 5.13 Lakh)** or
  3. Should have successfully erected and commissioned similar or higher rating work in maximum three turnkey/semi turnkey order, having minimum order value of 40% each of the estimated cost of the present tender specification. **(40% of Rs. 10.25 Lakh i.e. Rs. 4.10 Lakh)**


**B- Financial Requirement:-**

- i) The **Minimum Average Annual Turnover (MAAT)** for the best Three years out of the last Five Financial years MAAT should not be less than **Rs. 10.25 Lakh (100% of the estimated cost, i.e. 100% of Rs. 10.25 Lac)** duly Certified/Audited by Chartered Accountant.
- ii) **Net worth** of the bidder should be positive. 

**TERMS & CONDITIONS OF TENDER NO. T- 04/EUDC-III/2024-25,  
OPENING ON. 09.10.2024**

1. The work will be carried out at site as mentioned in Tender.
2. The quantity may vary by 10% on either side.
3. The work will be executed under Supervision of concerned Executive Engineer (Distribution), KESCo, Kanpur.
4. The rate quoted by the tenderer will be firm in all respect and no variation in plus side will be allowed during contractual period.
5. Labour, Vehicle, Crane, All T & P required for the work, will be arranged by the Contractor at his own Cost. Other materials as per schedule-P for the work will be provided by KESCo.
6. The contractual period will be 06 Months from the date of contract awarded to successful tenderer.
7. The offer should be valid for at least 06 Months.
8. All the damaged/replaced, unused and surplus materials will be the property of KESCo which will be returned by the contractor to KESCo immediately after completion of work.
9. Any loss/damage occurred to KESCo during Work will be the responsibility of the contractor and cost of such damages/losses will be payable by the contractor to KESCo.
10. The contractor will be fully responsible for any accident occurred to their staff deployed by him for the work. No claim in this regard will be admissible in KESCo.

These terms and conditions mentioned and indicated below shall be read and construed along with conditions of U.P.P.C.L. contract Form 'A' :
