Subject:-Deferment of Capacity charges/Rebate to distribution companies (DISCOMS) by central Generating and transmission companies of power for the lockdown period on account of COVID-19 pandemic.

Sir,

Kindly refer to Ministry of Power, Government of India Letter No. 11/16/2020-TH-II Dated 10.06.2020 on the subject mentioned above, vide which it was communicated that the central Generation/Transmission companies shall provide the rebate of Rs. 343.20 crores on their power bills (fixed charges) and interstate transmission charges for passing on to the end consumers for the lockdown period on account of Covid-19 pandemic.

In this reference, it is to inform that a rebate of Rs. 338.21 crores was confirmed by PSUs namely NHPC, NTPC, PGCIL, THDC, SJVNL, NVVN and MUNPL.

Further, as instructed the rebate of Rs. 342.68 crores has been passed on to the end consumers in their electricity bills as per the details given below:-
