**Sub: Corrigendum to Rate Schedule of Tariff Order FY 06-07**

Sir,

With reference to the tariff order dated 10<sup>th</sup> May 2007 for the FY 2006-07 and subsequent review order dated 13<sup>th</sup> July, 2007, wherein due to typographical errors under tariff schedule for consumers at 11 kV under HV-2 category, energy charges have been inadvertently prescribed as Rs. 3.50/kWh in place of Rs. 3.50/kVAh. Therefore, the energy charge on consumers at 11 kV HV-2 rate schedule should be read as Rs. 3.50/kVAh as these consumers are billed on kVAh basis.

Please also note that the review order dated 13<sup>th</sup> July, 2007 passed by the Commission on the tariff order 2006-07 shall apply in the entire State of Uttar Pradesh i.e. on all the distribution licensees viz PuVVNL, PaVVNL, DVVNL, MVVNL, KESCO and NPCL in view of the concept of uniform retail tariff across the State so long as the power purchase agreements are not allocated to individual distribution companies.
