PUBLIC NOTICE

Pursuant to Section 64 of the Electricity Act 2003, the Kesco, Kanpur submitted its Aggregate Revenue requirement for FY2013-14 on dated 03-12-2012 and other four Distribution companies viz Paschimanchal Vidyut Vitran Nigam Ltd., Poorvanchal Vidyut Vitran Nigam Limited, Madhyanchal Vidyut Vitran Nigam Limited and Dakshinanchal Vidyut Vitran Nigam Limited on dated 07-12-2012 before U.P. Electricity Regulatory Commission, Lucknow. The Hon'ble Commission vide its order dated 11-03-2013 has decided to initiate Suo-moto proceedings for determining the ARR and Tariff and issued tariff order for FY 2013-14 on 31-05-2013.
